



50/50 Fund Guidelines and Eligibility

My Rehab Answers Foundation, Inc Board of Directors Guidelines to Awarding

PURPOSE

My Rehab Answers Foundation Inc was founded to help people gain access to support and education through live support, community outreach, and funding for medical equipment. My Rehab Answers Foundation, Inc provides resources and services to enhance safety, independence, and quality of life. My Rehab Answers Foundation, Inc is recognized as a 501(c)3 tax-exempt charitable organization by the I.R.S.

REVIEW PROCESS

The individuals receiving this fund are chosen due to their need for medical equipment and / or home modifications in order to allow them to be safe and more independent at home. Applicants are chosen based on review of their application, discussion with ordering healthcare provider or contractor, financial need, and medical need. Funds are awarded based on cost of equipment / modifications and availability of funds.

ELIGIBILITY CRITERIA

Applicants must:

1. Be an individual in need of medical equipment or services that promote safety or independence.
2. Provide necessary documentation supporting the request (e.g. prescription, recommendation, proof of financial need).
3. Agree to provide feedback on the use or outcome of the equipment or service if requested.

Note: Priority may be given to those with urgent or high-impact needs.

APPLICATION PROCESS

1. **Submit Completed Application.** Complete the 50/50 Fund Application located on the website, including personal information, description of need, and supporting documentation. Return to foundation@myrehabanswers.com, subject 50/50 Fund.
2. **Review.** The Foundation Board will review applications for completeness and eligibility. Applications are reviewed on a first come first serve basis. Funds will be awarded based on a demonstrated need, impact, and alignment with the Foundation's mission. Each award is subject to the available Fund balance at the time of consideration.
3. **Decision and Notification.** Applicants will be notified of the Board's decision no later than 30 days of receipt of a complete application. If necessary, a special board meeting will be called to ensure timely review.

BOARD OF DIRECTORS GUIDELINES FOR AWARDING

1. Funds will be awarded based on demonstrated need, impact, and alignment with the Foundation's mission.
2. Each award is subject to the available Fund balance at the time of consideration.
3. Board members must declare any conflict of interest before reviewing an application involving family, friends, or close associates.
4. Decisions will be documented in meeting minutes, including the applicant's name, award amount, and purpose.
5. Funds may be provided directly to the applicant or directly to the vendor / provider supplying the equipment or service, at the Board's discretion.
6. Repeat applications may be considered but require new supporting documentation and justification.

PRIVACY DISCLAIMER

All personal and medical information provided in the application will be kept strictly confidential and used solely for the purpose of evaluating eligibility for the 50/50 Fund. Information will be reviewed only by Board members involved in the decision-making process. The Foundation will not share personal information with third parties without the applicant's explicit consent, except as required by law.
